For Family Child Care (linked):

The Bronze Checklist for Family Child Care (FCC) is a guide designed to help FCC providers meet the Step Up To Quality (SUTQ) Bronze Rating requirements in Ohio. It outlines the necessary steps, documentation, and standards that providers must follow to qualify for the rating.

For Centers (linked):

The Bronze Checklist for Centers is a guide to help child care centers meet the requirements for the Step Up To Quality (SUTQ) Bronze Rating in Ohio. It ensures that programs align with state standards for high-quality early learning and maintain the necessary documentation.

For School-Age (linked):

The Bronze Checklist for School-Age Programs helps child care centers and family child care (FCC) providers meet the Step Up To Quality (SUTQ) Bronze Rating requirements for school-age children (kindergarten and up). It ensures alignment with Ohio K-12 Learning Standards and best practices for quality care.

New! SUTQ Rules

The document above outlines learning and development standards for child care programs, categorized into Bronze, Silver, and Gold levels. It covers curriculum and assessment requirements, child screenings, staff qualifications, professional development, and leadership practices. Programs must follow research-based curricula, conduct regular child assessments and screenings, maintain proper staff-to-child ratios, and develop continuous improvement plans. It also emphasizes family engagement through needs assessments, referrals, and educational events to support child development and well-being.

ASQ Developmental Screening Program

The ASQ Developmental Screening Program from Help Me Grow Ohio helps families track children's development from birth to age five. Available through the Sparkler: Play for Parenting app, it provides screenings, expert guidance, and activities to support growth. Recommended by the American Academy of Pediatrics, screenings occur at key milestones. Families can access results via the app or get assistance by phone.
